**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 24 MAY 2019
AND
CHANGE OF AUDITOR**

The Board is pleased to announce that (1) all the ordinary resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 24 May 2019; and (2) KPMG has been appointed as auditor of the Company with effect from the conclusion of the AGM.

References are made to the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) and the circular (the “**Circular**”) of Golden Wheel Tiandi Holdings Company Limited (the “**Company**”) both dated 18 April 2019. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those used in the Circular.

RESULTS OF THE AGM

The Board is pleased to announce that all the ordinary resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 24 May 2019.

As at the date of the AGM, the total number of issued Shares was 1,802,456,000 Shares, representing the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions proposed at the AGM. No Shareholder was required to abstain from voting on any of the resolutions proposed at the AGM. There was also no Share entitling the Shareholders to attend and abstain from voting in favour of any of the resolutions proposed at the AGM and no Shareholder had indicated in the Circular his/her/its intention to vote against or to abstain from voting on the resolutions proposed at the AGM.

Computershare Hong Kong Investor Services Limited, the Company's branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
